Norwood Municipal Light Department Energy Star Appliance Rebate Incentive

Norwood Municipal Light Department (NMLD) is pleased to offer rebates to customers purchasing selected energy efficient ENERGY STAR refrigerators, central air conditioners, washing machine, dishwashers, unit air conditioners, computers, monitors or televisions during 2010. ENERGY STAR appliances have been defined by the Department of Energy (DOE) as being significantly more energy efficient than the average comparable model. *The advantages of purchasing ENERGY STAR appliances are:*

Potential savings in energy costs of 15 - 50%.

Reduction of global energy consumption and need for additional generation.

Decrease in pollution from fossil fuels used to generate electricity.

REBATE ELIGIBILITY REQUIREMENTS

- **Customer must reside at the address for which they have an active residential account with NMLD for a period of no less than six (6) months. Customer account must have a zero balance (with no arrears) for at least six months.**
- **Rebate will be applied as CREDIT to electric account and/or broadband account.**
- **Only selected ENERGY STAR refrigerators, central air conditioners, washing machine, dishwashers, unit air conditioners, computers, monitors or televisions are eligible for rebates. Appliances that qualify will have the ENERGY STAR logo on the yellow EnergyGuide label attached to the appliance (see illustration below).**
- **Customer must provide: 1) Proof of purchase in the form of a legible copy of sales receipt dated on or after January 1, 2010; 2) Copy of the yellow EnergyGuide label with the EnergyStar logo from the appliance purchased; 3) Completed Norwood Light ENERGY STAR Appliance Rebate Incentive application.**
- **Energy Star rebates: Refrigerators \$100; Central Air Conditioners \$100; Washing Machine \$50; Dishwashers \$50; Unit Air Conditioners \$25; Computers \$25, Monitors \$25 or Televisions \$25 (an additional \$25 for Computers, Monitors or Televisions for Norwood Light Broadband Customers).**
- **There is a limit of \$225 total rebate per residential account.**
- **Appliance must be installed at the account location.**
- **Appliances included in the purchase of a residence are not eligible.**
- **NMLD reserves the right to inspect the installation on the premises.**
